**The “Strategist UK’s Second Birthday Prize Draw” Terms and
Conditions**

1. **Eligibility:** The “Strategist UK’s Second Birthday Prize Draw” (the “Promotion”) is open to all legal residents of the United Kingdom at least 18 years of age or over at the time of entry who have internet access and a valid email address. Employees, independent contractors, interns, officers, directors, and agents of the Promoter (as defined below), as well as the immediate family members (spouse, parents, siblings, and children, and their respective spouses), household members, and any third party directly associated with administration of the Promotion are not eligible to enter or participate in the Promotion.

2. **No Purchase Necessary** The Promotion is free to enter and no purchase is necessary to enter or win.

3. **Entry Period:** The Promotion begins, and entries will be accepted online at the Promotion Website (defined below) starting at 12:00pm on 20/08/2021, and the closing date of the Promotion is 5:00pm on 30/08/2021 (“Entry Period”). Entries submitted before or after this time will not be eligible or considered. Promoter’s computer is the official time-keeping device for the Promotion.

4. **How to Enter:** All entries must be submitted via [ViralSweep](#). During the Entry Period, visit the Promotion Website and complete the official online entry form by filling out the requested information (which may include your name, age, and email address and completing the actions detailed on the Promotion Website. The entry must fulfill all Promotion requirements, as specified, to be eligible to win a prize.
